1. Opening by the Chairman, Mr. Hans Poulis

Chairman Hans Poulis opens the meeting and welcomes the members of the NHKBA and guests to the 44th Annual General Meeting of the NHKBA. He expresses his joy that the meeting could be held live but also regrets the relatively small number of members who showed interest in attending.

2. Approval of the Minutes of the Annual General Meeting held online on 28th April 2021 from 10:00 – 11:30 am.

The minutes were approved, without comments, by all participants with voting rights. The minutes can be found here.



3. New members & Cancellations in 2021

On behalf of the Board, Michael Pronk reports the following developments in the membership:

The NHKBA received cancellations from 8 corporate members and from 6 personal members.

In the same year, 5 new corporate (or partner) members and 5 new personal members registered.

By year's end the Association had

- 71 Corporate + associate + partner members (74 in 2020)
- 32 Personal members (33 in 2020)
- 3 Honoray members (4 in 2020)
- 4 Life members (4 in 2020)

Members total: 110 (115 in 2020)

In addition, the NHKBA had one honorary consultant, the Consul General in Hong Kong and 31 additional members (extra contacts at corporate or partner members).

Grand total: 141 (143 in 2021)

The reasons for cancelling the membership remained in 2021:

- a. No longer focussed on HK (due to change of business focus, retirement or age)
- b. Retirement of main contact (new contact has no interest)
- c. No benefit from membership (no new business)

Mr Pronk next presents new Membership Packages. He starts of with the statement "As the business environment in Hong Kong is changing, the NHKBA needs to grow from a HK business community to a value adding, membership driven GBA Business Ecosystem.

Following the presentation of the proposed membership fees (see presentation), it was decided to set the Bronze (basic) membership fee at \in 488 Euro (now \in 450), the fee for the Silver membership will be \in 988 and the amount for the Gold Membership \in 1,988.

The board introduced the fees per January 1, 2022 and the members voted 100% in favour of the proposal made.

The Chairman explains that Ms Baud and Mr Van Naarden have resigned from the board of the NHKBA in 2021. He thanks both for their support and commitment to the NHKBA and hopes they will join future meetings as personal members.

The Chairman asks the approval of the AGM for the appointment on the board of mr Maarten Van der Dussen, founder and CEO of ProductIP.

The AGM approves the appointment.
